INTRODUCTION

Ontario families have been through a lot the last few years. The cost of living is skyrocketing, and families need a break. New Democrats have a plan to make critical investments in key sectors of our economy to help Ontario families while driving economic growth.

Our plan to build transit, make childcare universally accessible, reinvest in our healthcare and education systems, and raise wages will strengthen jobs and the pandemic recovery. We will freeze taxes for the working class, cancel wasteful projects, and invest instead in infrastructure projects that will actually cut commute times, the cost of transit, and greenhouse gas emissions.

Our plan is prudent, not based on fictitious federal dollars, and it reflects Ontario's economic reality. It is also ready to go, so we can deliver on it now, not years into the future.

Andrea Horwath and the NDP have based our fiscal plan on four principles:

- We will make investments that make life better for everyone.
- We will protect middle-class families from tax hikes and fee increases.
- We will ensure the wealthiest people and most profitable corporations pay their fair share for our public services.
- We will make sure our investments are financially sustainable.

Our changes:

- We will undo the Liberal corporate income tax cut and return the corporate rate to 13% in a fair manner that allows businesses to plan.
- We will maintain the small business rate at 3.2%.
- We will ask the wealthiest among us to pay their fair share by raising income tax on amounts earned over \$220,000 by one percentage point, and on earnings over \$300,000 by two percentage points.
- We will add a surtax on luxury vehicles of 5% for vehicles between \$90,000-100,000, and 7% on vehicles over \$100,000.
- We will tax the richest 1% by raising capital gains that are included in taxable income from 50% to 100% on corporations (excluding small businesses), and individuals with a net worth over \$3 million. This new capital gains adjustment includes a primary residence exemption.
- We will cancel Highway 413 and the Bradford Bypass and redirect funds to social and health infrastructure.

Fiscal approach

Our new costs and revenues use Ontario's Budget 2022 as the base. We have kept our projections cautious and prudent.

Our investments are targeted in areas that need it most. Over just the next three years, New Democrats will invest:

- \$13.6 billion in our healthcare, homecare, and long-term care systems to ensure that healthcare services are there where and when you need them, including
 - \$2.4 billion in a universal mental health care program
 - \$1.8 billion for comprehensive dental coverage for families
 - o Nearly \$1 billion towards pharmacare
- \$18 billion to radically transform social assistance by doubling ODSP and OW in year two
- \$3.1 billion in our schools, plus \$4.8 billion in capital expenditures to clear the school repair backlog
- \$2.9 billion towards new and affordable housing

Capital Plan

The New Democrat capital plan will match the government budget's planned \$158.8 billion in infrastructure investment. However, an NDP government will make different choices. Rather than proceeding with \$12 billion to construct projects like Highway 413 and the Bradford Bypass, an NDP Government will invest in school repair and construction, and desperately needed additional health care infrastructure.

Green New Democratic Deal

Our Green New Democratic Deal is a stand-alone costed plan for tackling the climate crisis. We expect that the new funding generated from re-entering the cap-and-trade market and additional financing from ramping up Green Bonds is \$39.6 billion.
